A number of criteria have been established to make reading, updating and retrieving an easy task. 92 Italian companies are listed in alphabetical order. Their activities and legal status are shown as well as their lines of business. Among the listed companies, 59% are located in New South Wales and 30% in Victoria. 58% of the companies deal with industrial goods, 29% with consumer goods, whilst 13% provide services. The Italian Trade Commission has checked the information with the interested parties, however this list may not to be exhaustive of all Italian companies present in Australia.
